(General Surgery) on an equivalent qualification as prescribed by the said Council in its recommendations on Post graduate Medical Examination.

After 1998, for teaching appointments in super Speciality of Gastro-Intestinal Surgery, the candidates must possess Post-Graduate degree qualification in the Speciality concerned, that is D.M./M.Ch. after M.D./M.S. or other qualifications as may be approved by the Council from time to time. The existing alternative qualification that is M.S. or an equivalent qualification with two years special training in a recognised training centre in the speciality concerned shall cease to be sufficient qualification for appointment to aforesaid teaching posts from that date.

Note: 7 This list is not exhaustive. The Controlling Authority in consultation with the Union Public Service Commission shall have the power to assign other qualifications to Part-A, B, C or D.
