Officers under the Central Government or States Government or Union Territories or Public Sector Undertakings or Recognised Research Institutions or Universities or Statutory or Autonomous Organisations:-

- (a) (i) Holding analogous post on regular basis in the parent cadre or department; or
 - (ii) With seven years' service in the grade rendered after appointment thereto on regular basis in level 7 in the pay matrix or equivalent in the parent cadre or department; and
- (b) Possessing the following educational qualification and experience:-

Essential:

- (i) Master's degree in Library Science or Library and Information Science of a recognized University or Institution.
- (ii) Five years professional experience in a Library under Central Government or States Government or statutory or autonomous organisations or Public Sector Undertakings or Universities or recognised research or educational Institutions.

Desirable:

(i) One year experience of computerizing library activities in a library under Central Government or States Government or statutory or autonomous organisations or Public Sector Undertakings or Universities or recognised research or educational Institutions.

Deputation or re-employment (for ex-servicemen):

The Armed Forces Personnel of the rank of Lieutenant Commander (IN) or equivalent due to retire or who are to be transferred to reserve within a period of one year and having the requisite qualification and experience prescribed for deputation (including short term contract) shall also be considered. Such persons would be given deputation terms up to the date on which they are due for release from the Armed Forces; thereafter they may be continued on re-employment.

Note 1: The Departmental Officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short term contract plus promotion) including period of deputation (Including short term contract plus promotion) in another Ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not to exceed three years.

Note 3: The maximum age-limit for appointment by deputation (including short term contract) shall be not exceeding fifty six years as on the closing date of the receipt of applications.
